### Matters Arising

- BT response was read. They have quoted £4000+ for initial consultation/feasibility survey. JL will follow up.
- Map funding: AP reported that only funds available (via S.Newby's office) are from Cllr Bailey (who can fund up to 75% of a project) – he has quotes from Headland for different size print runs. After discussion it was agreed to request £450 and research other sources for increased print run. W.Greyhound have not yet responded.
- PCT response to Dental care letter received.
- Christmas light – have been purchased at cost of £80. Agreed to pay £40 and ask Village Hall committee for balance.
- Heath Forum: last meeting was more positive, future meetings arranged, Forum will be widened.
- Airwave: Cllr Bailey will follow up letter to Planning Dept.
- Car Park: nothing heard from Enforcement. NT have inspected but not yet reported.
